April 20, 2010: Introduced as Council Bill 12, Series 2010 by Councilor Scott Roswell, seconded by Councilor Klasina VanderWerf, and considered in full text on first reading. Passed by a vote of 5 yes and 0 no.

May 4, 2010: Considered in full text on second reading. Passed by a vote of 6 yes and 0 no.

**A BILL FOR AN ORDINANCE
 OF THE CITY OF CHERRY HILLS VILLAGE,
 AUTHORIZING A SUPPLEMENTAL APPROPRIATION
 FOR THE REPAIR AND REPLACEMENT OF
 THE ASPHALT ROAD SURFACE ON SOUTH FRANKLIN STREET DUE TO THE
 CONSTRUCTION OF A DENVER WATER MAIN**

WHEREAS, the City of Cherry Hills Village desires to complete repaving of the southbound lane of South Franklin Street which has become necessary as a result of the water main replacement project done by Denver Water in 2009; and

WHEREAS, pursuant to the requirements outlined in the City's Construction and Excavation Standards and agreed to in the correspondence from Denver Water representatives dated March 25, 2010, the total cost of this project will be reimbursed to the City by the Denver Water Board; and

WHEREAS, this project is important to the City's transportation infrastructure; and

WHEREAS, the City desires to complete this project in 2010, but the expenditure was not included in the 2010 budget; and

WHEREAS, performing these operations at this time is necessary to provide for the health, safety, and welfare of the City's residents; and

WHEREAS, it was unforeseen that the City would be managing this project for Denver Water, during the 2010 fiscal year; and

WHEREAS, the City Council desires to commence the necessary improvements during 2010 for the reasons set forth herein.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS
 VILLAGE, COLORADO, ORDAINS:**

Section 1. That the 2010 Budget and Appropriations be hereby supplemented by increasing the following funds and accounts, to-wit:
