May 4, 2010: Introduced as Council Bill 14, Series 2010 by Councilor Klasina VanderWerf, seconded by Councilor Alex Brown, and considered in full text on first reading. Passed by a vote of 6 yes and 0 no.

May 18, 2010: Considered in full text on second reading. Passed by a vote of 6 yes and 0 no.

**A BILL FOR AN ORDINANCE
 OF THE CITY OF CHERRY HILLS VILLAGE
 AMENDING CHAPTER 18 OF THE CHERRY HILLS VILLAGE MUNICIPAL CODE,
 CONCERNING BUILDING REGULATIONS, BY AMENDING ARTICLE X, SECTION 70(f)
 CONCERNING ENFORCEMENT AND FINES**

WHEREAS, the City of Cherry Hills Village is a home rule municipal corporation organized in accordance with Article XX of the Colorado Constitution; and

WHEREAS, the City Council has determined to amend the City of Cherry Hills Village Municipal Code ("Municipal Code") to address the schedule of fines for violating provisions of the Municipal Code relating to construction practices.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:

That Section 18-10-70(f) of the City of Cherry Hills Village Municipal Code is hereby amended to read as follows:

Sec. 18-10-70. Enforcement

(f) Upon the first conviction of a person for a violation of any provision of this Article, there shall be imposed a fine of not less than two hundred fifty dollars (\$250.00). Upon the second conviction of a person for violation of the same provision of this Article for which he or she was previously convicted, there shall be imposed a fine of not less than five hundred dollars (\$500.00). Upon the third and each subsequent conviction of a person for violation of the same provision of this Article for which he or she was previously convicted, there shall be imposed a fine of not less than one thousand dollars (\$1,000.00). Notwithstanding the foregoing, a violation shall not be considered a second or third and subsequent violation, subject to the increased fines described herein, if date of the violation which results in a conviction occurs more than three (3) years after a previous conviction of the same provision of this Article.


