**A RESOLUTION  
OF THE CITY COUNCIL  
OF THE CITY OF CHERRY HILLS VILLAGE  
CONCERNING THE REAPPOINTMENT OF A MEMBER  
AND APPOINTMENT OF NEW MEMBERS  
TO THE PUBLIC ART COMMISSION**

**WHEREAS**, Section 3.1 of the City of Cherry Hills Village City Charter authorizes the City Council to "delegate to board and commissions...such functions, powers and authority of the City as it deems proper and advisable"; and

**WHEREAS**, Resolution 6, Series 2011 established the Public Art Commission; and

**WHEREAS**, the term of appointment of Chair Ann Polumbus will expire on the third Tuesday of May 2017; and

**WHEREAS**, Chair Polumbus has expressed her desire to be reappointed to another term; and

**WHEREAS**, the City Council desires to reappoint Chair Polumbus to a new term on the Public Art Commission; and

**WHEREAS**, at the March 7, 2017 meeting, City Council approved Resolution 10, Series 2017 to increase the number of members on the Commission from five to seven, not including a Council representative; and

**WHEREAS**, three new openings on the Commission need to be filled; and

**WHEREAS**, applications to serve on the Commission were reviewed by Mayor Laura Christman and Councilor Katy Brown; and

**WHEREAS**, Mayor Laura Christman and Councilor Katy Brown have recommended that the Council appoint Alison Lynch, David Schmidt and Kathie Finger to fill the new openings on the Commission.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE THAT:**

The City Council hereby makes the following appointment to the City of Cherry Hills Public Art Commission:
