

**ORDINANCE NO. 2**  
**Series 2018**

February 20, 2018: Introduced as Council Bill 2, Series 2018 by Councilor Randy Weil, seconded by Councilor Earl Hoellen and considered in full text on first reading. Passed by a vote of 5 yes and 0 no.

March 6, 2018: Considered in full text on second reading. Passed by a vote of 6 yes and 0 no.

**A BILL FOR AN ORDINANCE  
 OF THE CITY OF CHERRY HILLS VILLAGE,  
 AUTHORIZING A SUPPLEMENTAL APPROPRIATION  
 IN THE CAPITAL FUND FOR FISCAL YEAR 2018  
 FOR DESIGN AND CONSTRUCTION OF TRAFFIC IMPROVEMENTS  
 AT COLORADO BOULEVARD AND QUINCY AVENUE**

**WHEREAS**, the City Council of the City of Cherry Hills Village may authorize supplemental appropriations by ordinance for unbudgeted expenditures; and

**WHEREAS**, the City Council has examined traffic issues throughout the City; and

**WHEREAS**, the City Council has determined that the traffic congestion along Quincy Avenue near the main entrance of Kent Denver School and the intersection of Colorado Boulevard and Quincy Avenue poses a concern for the public health, safety and welfare; and

**WHEREAS**, the City Council has determined that construction of traffic improvements including a roundabout at the intersection of Colorado Boulevard and Quincy Avenue ("Roundabout") will serve the public good and improve public health, safety and welfare; and

**WHEREAS**, the City Council desires to fund, design and construct the Roundabout within the 2018 budget; and

**WHEREAS**, the City Council approves the transfer of funds from the General Fund balance in the amount of \$500,000 and from the Parks and Recreation Fund balance in the amount of \$250,000 to the Capital Fund balance for a total of \$750,000 for this project; and

**WHEREAS**, in accordance with Section 9.10 of the Home Rule Charter, the City Council desires to make an additional appropriation of \$750,000 in the 2018 budget for the expenditure related to installation of a Roundabout as set forth herein.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS  
 VILLAGE, COLORADO, ORDAINS:**

**Section 1.** That the 2018 Budget and Appropriations is hereby supplemented by increasing the following fund and account, to-wit:

**Capital Fund 02-441-3112 Right-Of-Way Improvements**  
 As determined on or before December 31, 2018

From	To
\$100,000	\$850,000

**Section 2.** The City Council hereby ratifies all expenditures heretofore and hereafter made pursuant to this supplemental appropriation ordinance.




