April 17, 2018: Introduced as Council Bill 4, Series 2018 by Councilor Katy Brown, seconded by Councilor Al Blum and considered in full text on first reading. Passed by a vote of 5 yes and 0 no.

May 1, 2018: Considered in full text on second reading. Passed by a vote of 5 yes and 0 no.

**A BILL FOR AN ORDINANCE
 OF THE CITY OF CHERRY HILLS VILLAGE,
 AMENDING THE 2018 BUDGET TO TRANSFER PREVIOUSLY APPROPRIATED FUNDS
 FOR THE DESIGN AND CONSTRUCTION OF A PROPOSED SINGLE-LANE ROUNDABOUT
 TRAFFIC IMPROVEMENT AT COLORADO BOULEVARD AND QUINCY AVENUE,
 AUTHORIZED BY ORDINANCE NO. 2, SERIES 2018, TO THE GENERAL FUND AND THE
 PARKS AND RECREATION FUND, AND TO REMOVE THE \$750,000 APPROPRIATION
 FROM THE 2018 CAPITAL FUND BUDGET, LESS ANY FUNDS EXPENDED TO DATE**

WHEREAS, in accordance with its Home Rule Charter, the City Council of the City of Cherry Hills Village may authorize supplemental appropriations by ordinance for unbudgeted expenditures; and

WHEREAS, the City Council has examined traffic issues throughout the City; and

WHEREAS, the City Council determined that the traffic congestion along Quincy Avenue near the main entrance of Kent Denver School and the intersection of Colorado Boulevard and Quincy Avenue during peak times poses a concern for the public health, safety and welfare; and

WHEREAS, following a traffic engineering study on appropriate traffic improvement measures, the City Council authorized the preliminary design of a potential single-lane roundabout at the intersection of Colorado Boulevard and Quincy Avenue ("Roundabout"); and

WHEREAS, in accordance with Section 9.10 of the Home Rule Charter, the City Council enacted Ordinance No. 2, Series 2018, approving the transfer of funds from the General Fund in the amount of \$500,000 and from the Parks and Recreation Fund in the amount of \$250,000 to the Capital Fund for a total of \$750,000 for the design and construction of the Roundabout, subject to further City Council review and approval of such Roundabout; and

WHEREAS, the City Council conducted a public meeting on April 3, 2018, to receive public input regarding the potential Roundabout; and

WHEREAS, based on strong community opposition to the proposed construction of a Roundabout at Quincy Avenue and Colorado Boulevard, City Council elected to not proceed further with the design of the Roundabout and directed staff to return the \$500,000 to the General Fund and the \$250,000 to the Parks and Recreation Fund and remove the \$750,000 appropriation from the 2018 Capital Fund budget, less any funds expended to date.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:

Section 1. That the 2018 Budget and Appropriations is hereby amended by increasing/decreasing the following funds and account, to-wit:

Capital Fund 02-441-3112 Right-Of-Way Improvements
 As determined on or before December 31, 2018

From	To
\$850,000	\$130,000

Section 2. The City Council hereby ratifies all expenditures heretofore and hereafter made pursuant to this supplemental appropriation ordinance.



Adopted as Ordinance No. 4, Series 2018, by the City Council of the City of Cherry Hills Village, Colorado this 1st day of May, 2018.




