Series 2019

August 20, 2019: Introduced as Council Bill 5, Series 2019 by Mayor Pro Tem Brown, seconded by Councilor Dan Sheldon and considered in full text on first reading. Passed by a vote of 6 yes and 0 no.

September 3, 2019: Considered in full text on second reading. Passed by a vote of 6 yes and 0 no.

A BILL FOR AN ORDINANCE OF THE CITY OF CHERRY HILLS VILLAGE, AUTHORIZING A SUPPLEMENTAL APPROPRIATION IN THE CATHERINE H. ANDERSON LAND DONATION FUND FOR FISCAL YEAR 2019 FOR THE QUINCY FARM SANITARY SEWER CONSTRUCTION PROJECT

WHEREAS, in accordance with Article IX of the Home Rule Charter, the City Council of the City of Cherry Hills Village budgeted and appropriated funds in 2018 for the Quincy Farm Sanitary Sewer Construction Project ("Project"); and

WHEREAS, the work related to such appropriation was not completed in 2018, and the 2019 budget does not authorize any expenditure of City funds for the Project; and

WHEREAS, the City Council desires to properly authorize and account for expenditures for the Project in the 2019 budget document; and

WHEREAS, in accordance with Section 9.10 of the Home Rule Charter, the City Council desires to make an additional appropriation in the amount of \$112,000.00 in the 2019 budget for the necessary expenditures related to the Project as set forth herein; and

WHEREAS, the additional appropriation contemplated by this Ordinance does not exceed the amount by which actual and anticipated revenues of the year are exceeding the revenues as estimated in the 2019 budget.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:

Section 1. That the 2019 Budget and Appropriations is hereby supplemented by increasing the following fund and account, to-wit:

Catherine H. Anderson Land Donation Fund 08-08-450-6068

As determined on or before December 31, 2019




