

ORDINANCE NO. 29

Series 2010

November 16, 2010: Introduced as Council Bill 27, Series 2010 by Councilor Roswell, seconded by Mayor Pro Tem Stewart, and considered in full text on first reading. Passed by a vote of 5 yes and 0 no.

December 14, 2010: Considered in full text on second reading. Passed by a vote of 5 yes and 0 no.

A BILL FOR AN ORDINANCE OF THE CITY OF CHERRY HILLS VILLAGE GRANTING A WATER SERVICE LINE EASEMENT WITHIN THE BILLYNNE SUBDIVISION TO DENVER BOARD OF WATER COMMISSIONERS.

WHEREAS, pursuant to its Home Rule Charter, the City Council of the City of Cherry Hills Village is expressly authorized to own, possess, and hold real property and to sell and dispose of such real property; and

WHEREAS, the City and County of Denver, acting by and through its Board of Water Commissioners (the "Board"), requests an easement along City property located on the north side of Cherry Lane Drive in order to provide water service to residential lots adjacent to the requested easement; and

WHEREAS, the City Council finds and determines that this Ordinance is reasonably necessary to promote the legitimate public purposes of the public health, safety and welfare.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:

Section 1: The City of Cherry Hills Village shall grant a water service line easement to the City and County of Denver, acting by and through its Board of Water Commissioners, and hereby approved the Easement Agreement, attached hereto as Exhibit A, and the Mayor of the City of Cherry Hills Village is hereby authorized to execute the Easement Agreement on behalf of the City Council.
