March 1, 2010: Introduced as Council Bill 8, Series 2010 by Mayor Pro Tem Russell Stewart, seconded by Councilor Mark Griffin, and considered in full text on first reading. Passed by a vote of 4 yes and 0 no.

March 15, 2010: Considered in full text on second reading. Passed by a vote of 6 yes and 0 no.

**A BILL FOR AN ORDINANCE  
OF THE CITY OF CHERRY HILLS VILLAGE  
AUTHORIZING A SUPPLEMENTAL APPROPRIATION  
FOR THE EXPENDITURE OF FUNDS FOR THE DRY CREEK TRAIL IMPROVEMENTS  
FOR FISCAL YEAR 2009**

**WHEREAS**, the City of Cherry Hills Village received a grant in 2007 in the amount of \$240,600 from Arapahoe County for the Big Dry Creek Trail project; and

**WHEREAS**, the expenditure of these funds was made in 2009, but were not included in the 2009 budget; and

**WHEREAS**, the City desires to amend the 2009 budget to include the expenditure for the project and the grant revenue.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:**

Section 1. That the 2009 Budget and Appropriations be hereby supplemented by increasing the following funds and accounts, to-wit:

Parks and Recreation Fund 30-441-1000

Trail Improvements	\$10,000.00	\$250,000.00


Parks and Recreation Fund 30-360-3680
