

**ORDINANCE NO. 2
Series 2009**

March 17, 2009: Introduced as Council Bill 3, Series 2009 by Councilmember VanderWerf, seconded by Councilmember LaMair, and considered by the title only on first reading. Passed by a vote of 6 yes and 0 no.

April 7, 2009: Considered in full text on second reading. Passed by a vote of 6 yes and 0 no.

**A BILL FOR AN ORDINANCE
OF THE CITY OF CHERRY HILLS VILLAGE,
AUTHORIZING A SUPPLEMENTAL APPROPRIATION
FOR THE REPAIR AND REPLACEMENT OF
SANITARY SEWER LINES, WATER LINES, AND
THE CONSTRUCTION OF A PICNIC SHELTER
FOR FISCAL YEAR 2009**

WHEREAS, the City of Cherry Hills Village desires to complete a number of projects budgeted in 2008; and

WHEREAS, these projects were inadvertently excluded from the budget process for 2009; and

WHEREAS, these projects are important to the City's water, sewer and parks infrastructure; and

WHEREAS, the City desires to complete these projects in 2009; and

WHEREAS, performing these operations at this time is necessary to provide for the health, safety, and welfare of the City's residents; and

WHEREAS, although these projects were not budgeted for the 2009 fiscal year, the City Council desires to commence the necessary improvements during 2009 for the reasons set forth herein.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:

Section 1. That the 2009 Budget and Appropriations be hereby supplemented by increasing the following funds and accounts, to-wit:


