

**ORDINANCE NO. 9  
Series 2009**

June 16, 2009: Introduced as Council Bill 8, Series 2009 by Councilmember Klasina VanderWerf, seconded by Councilmember Harriet LaMair, and considered by the title only on first reading. Passed by a vote of 4 yes and 2 no.

July 21, 2009: Considered in full text on second reading. Passed by a vote of 5 yes and 1 no.

**A BILL FOR AN ORDINANCE  
OF THE CITY OF CHERRY HILLS VILLAGE,  
AUTHORIZING A SUPPLEMENTAL APPROPRIATION  
TO TRANSFER MONEY FROM THE GENERAL FUND  
TO THE CATHERINE H. ANDERSON LAND DONATION FUND**

**WHEREAS**, the City of Cherry Hills Village City Council adopted Resolution 4, Series 2009 at the May 5, 2009 City Council meeting; and

**WHEREAS**, Resolution 4 established the Catherine H. Anderson Open Space Program to foster and encourage natural open space preservation through financial assistance to residents interested in preserving Village natural areas; and

**WHEREAS**, as a result of said resolution, Fund 8 was renamed the Catherine H. Anderson Land Donation Fund; and

**WHEREAS**, the Catherine H. Anderson Land Donation Fund is to be utilized for the primary purpose of acquisition of open space, parks and trails, and

**WHEREAS**, currently the Catherine H. Anderson Land Donation Fund is comprised of monies from cash-in-lieu dedications associated with subdivision applications, private monetary donations received by the City, and sums from any other methods the City Council may utilize to fund the account; and

**WHEREAS**, the City Council desires to transfer a portion of the General Fund balance to the Catherine H. Anderson Land Donation Fund for the purpose of further enhancing the Fund; and

**WHEREAS**, although this transfer was not budgeted for in the 2009 fiscal year, the City Council desires to transfer the funds during 2009 for the reasons set forth herein.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:**


Section 1. That the 2009 Budget and Appropriations be hereby supplemented by increasing the following funds and accounts, to-wit:

Section 2. The City Council hereby ratifies all expenditures heretofore and hereafter made pursuant to this supplemental appropriation ordinance.




