

ORDINANCE NO. 04
Series 2008

January 15, 2008: Introduced as Council Bill 1, Series 2008 by Councilmember Russell Stewart, seconded by Councilmember Klasina VanderWerf, and considered by the title only on first reading. Passed by a vote of 4 yes and 0 no.

February 19, 2008: Considered in full text on second reading. Passed by a vote of 6 yes and 0 no.

A BILL FOR AN ORDINANCE
OF THE CITY OF CHERRY HILLS VILLAGE
AMENDING SECTION 2-4-130 OF THE CHERRY HILLS VILLAGE MUNICIPAL
CODE CONCERNING FEES FOR JURY SERVICE

WHEREAS, the City of Cherry Hills Village (the "City") is a home rule municipal corporation organized in accordance with Article XX of the Colorado Constitution; and

WHEREAS, pursuant to City Charter Section 7.1, the City has established a municipal court and empowered the City Council to provide for jury service in such court; and

WHEREAS, in accordance with the recommendation of the municipal court judge, the City Council finds and determines that it is desirable to increase the fees for jury service currently in effect.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:


Section 1. That paragraph (3) of Subsection 2-4-130(b) of the City of Cherry Hills Village Municipal Code, concerning jury fees, is hereby amended as follows:

(3) Jury fees. Persons summoned to jury duty pursuant to this Article shall be entitled to a juror's fee of ~~three dollars (\$3.00)~~ five dollars (\$5.00) per day during the jury selection process; those persons selected for jury service shall be entitled to a juror's fee of ten dollars (\$10.00) per day of such service in lieu of the five dollar (\$5.00) fee.


Section 2. Severability. If any provision of this ordinance should be found by a court of competent jurisdiction to be invalid, such invalidity shall not affect the remaining portions or applications of this ordinance that can be given effect without the invalid portion, provided that such remaining portions or applications of this ordinance are not determined by the court to be inoperable. The City Council declares that it would have adopted this Ordinance and each section, subsection, sentence, clause, phrase, or portion thereof, despite the fact that any one or more section, subsection, sentence, clause, phrase, or portion would be declared invalid.

Section 3. Effective Date. This ordinance shall take effect in accordance with the City of Cherry Hills Village Home Rule Charter.
