December 12, 2006: Introduced as Council Bill 09, Series 2006 by Councilmember Doug Tisdale, seconded by Councilmember Bonnie Blum, and considered by the title only on first reading. Passed unanimously.

January 16, 2007: Considered in full text on second reading. Passed unanimously.

**A BILL FOR AN ORDINANCE  
OF THE CITY OF CHERRY HILLS VILLAGE,  
AUTHORIZING A SUPPLEMENTAL  
APPROPRIATION FOR FISCAL YEAR 2006**

WHEREAS, the City of Cherry Hills Village has budgeted an interest payment of \$263,000 in Fund 30 in 2006 for the asset payment expense to South Suburban; and

WHEREAS, the Final Order of Exclusion states that "interest shall be calculated for each payment based on the interest rate of the two-year U.S. Treasury Note as of November 15 of the preceding year."

WHEREAS, the two-year U.S. Treasury Note as of November 15, 2005 increased from 2.890% in 2004 to 4.470% in 2005; and

WHEREAS, the City of Cherry Hills Village must make an interest payment of \$431,839 for the asset payment expense to South Suburban in 2006; and

WHEREAS, the City Council, pursuant to Article IX of the City Charter, desires to ratify and authorize a supplemental appropriation in the amount of these additional funds.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:

Section 1. That the 2006 Budget and Appropriations be an additional \$168,839.00 for Fund 30.

Section 2. The City Council hereby ratifies all expenditures heretofore and hereafter made pursuant to this supplemental appropriation ordinance.
