RESOLUTION
OF THE CITY COUNCIL
OF THE CITY OF CHERRY HILLS VILLAGE
APPROVING AN INTERGOVERNMENTAL AGREEMENT
WITH URBAN DRAINAGE AND FLOOD CONTROL DISTRICT FOR DRAINAGE AND
MAINTENANCE IMPROVEMENTS ON LITTLE DRY CREEK AT WOODIE HOLLOW PARK,
AGREEMENT NO. 15-10.12

WHEREAS, C.R.S. Section 29-1-203 authorizes governments to cooperate or contract with one another to provide any function, service, or facility; and

WHEREAS, Section 13.6 of the Cherry Hills Village Home Rule Charter authorizes the City Council, by resolution or by ordinance, to enter into contracts or agreements with other governmental units or special districts for receiving services; and

WHEREAS, the City has been working with Urban Drainage and Flood Control District ("UDFCD") for a number of years on erosion control projects on Little Dry Creek as it runs through Woodie Hollow Park; and

WHEREAS, the City Council desires to enter into that certain Agreement Regarding Maintenance of Drainage and Flood Control Improvements for Little Dry Creek at Woodie Hollow Park Cherry Hills Village (Agreement No. 15-10.12) with UDFCD, a copy of which is attached to this Resolution as **Exhibit A** and is incorporated herein by reference ("UDFCD IGA"); and

WHEREAS, the UDFCD IGA will facilitate the completion of additional drainage and maintenance improvements within Woodie Hollow Park and private property abutting Woodie Hollow Park located at 10 Cherry Vale Drive; and

WHEREAS, the expenditure of City funds under the UDFCD IGA will not exceed forty thousand dollars (\$40,000.00), unless an amendment to the UDFCD IGA is approved by City Council.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Cherry Hills Village, Colorado that:

Section 1. The City Council hereby: (a) approves the UDFCD IGA in substantially the same form as attached hereto as **Exhibit A**, subject to minor modifications that do not increase the City's financial obligations and review and approval of any such modifications by the City Manager and City Attorney; and (b) authorizes the Mayor or Mayor Pro Tem to execute the UDFCD IGA on behalf of the City when in final form.

Section 2. This Resolution shall be effective immediately.
