February 5, 2002: Introduced as Council Bill 01 Series 2002 by Doug Tisdale, seconded by Bonnie Blum, and considered by the title only on first reading. Passed unanimously.

February 19, 2002: Considered in full text on second reading. Passed unanimously. Designated as Ordinance No. 6, Series 2002.

A BILL FOR AN ORDINANCE OF THE CITY OF CHERRY HILLS VILLAGE REPEALING AND READOPTING CHAPTER 7 OF TITLE 3 OF THE CITY CODE, TO APPROVE A CABLE FRANCHISE AGREEMENT BY AND BETWEEN MOUNTAIN STATES VIDEO COMMUNICATIONS CO., INC. AND THE CITY OF CHERRY HILLS VILLAGE, COLORADO

WHEREAS, the City of Cherry Hills Village is a home rule municipal corporation organized in accordance with article XX of the Colorado Constitution; and

WHEREAS, Article XII of the City Code for the City of Cherry Hills Village authorizes the City Council to approve franchise agreements by ordinance; and

WHEREAS, the City Council desires to enter into a franchise agreement for the provision of cable services as more specifically described in the "Cable Franchise Agreement" by and Between Mountain States Video Communications Co., Inc. and the City of Cherry Hills Village, Colorado attached hereto and incorporated herein; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:

Section 1. Chapter 7 of Title 3 of the City Code for the City of Cherry Hills Village, entitled "CONDITIONS AND REGULATIONS PERTAINING TO THE ISSUANCE OF A PERMIT OR PERMITS FOR CABLE TELEVISION SYSTEM IN THE CITY" is hereby repealed in its entirety and reenacted to read in full as follows:


**CHAPTER 11
CABLE FRANCHISE AGREEMENT**

SECTION:

3-7-1 Approval of Cable Franchise Agreement

3-7-1: **APPROVAL OF CABLE FRANCHISE AGREEMENT:** The "Cable Franchise Agreement" by and between Mountain States Video Communications Co., Inc. and the City of Cherry Hills Village, Colorado, which is incorporated herein as if set forth in full, is approved by the City Council. The Cable Franchise Agreement shall be available for public inspection during normal business hours from the City Clerk at the offices of the City of Cherry Hills Village.

Adopted as Ordinance No. 6, Series 2002, by the City Council of the City of Cherry Hills Village, Colorado this 19th day of February, 2002.


