

**ORDINANCE 9**  
**SERIES 2002**

February 19, 2002: Introduced as Council Bill 02 Series of 2002 by Jan Steiert, seconded by Bonnie Blum, and considered by the title only on first reading. Passed with a vote of 4 yes and 1 no.

March 5, 2002: Considered in full text on second reading. Passed with a vote of 4 yes and 1 no. Designated as Ordinance No. 09, Series 2002.

**A BILL FOR AN ORDINANCE OF THE CITY OF CHERRY HILLS VILLAGE, AUTHORIZING A SUPPLEMENTAL APPROPRIATION FOR FISCAL YEAR 2002**

WHEREAS, the Administration of the City of Cherry Hills Village desires to add an additional Administrative Clerk for the express purpose of being an assistant to the City Manager; and

WHEREAS, the Public Works Department of the City of Cherry Hills Village desires to purchase a street sweeper that was approved in the 2002 Budget; and

WHEREAS, the said street sweeper desired for purchase is more that the amount originally budgeted; and

WHEREAS, the City of Cherry Hills Village has authorized and approved the construction of the water improvement system known as Special Improvement District # 7; and

WHEREAS, the construction of the water improvement system was to be completed and was budgeted for completion in 2001; and

WHEREAS, the construction is continuing in the year 2002 but funds have not yet been budgeted in 2002 for the construction; and

WHEREAS, sufficient surplus funds exist in the General Fund as well as the Special Improvement District #7 Fund 13 to cover the cost of these expenditures; and

WHEREAS, the City Council, pursuant to Article IX of the City Charter desires to ratify and authorize a supplemental appropriation in the amount of these additional expenditures.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:


Section 1. That the 2002 Budget and Appropriations be hereby supplemented by increasing the following Funds to-wit:

Section 2. The City Council hereby ratifies all expenditures heretofore and hereafter made pursuant to this supplemental appropriation ordinance.

Section 3. Severability. If any provision of this ordinance should be found by a court of competent jurisdiction to be invalid, such invalidity shall not affect the remaining portions or applications of this ordinance that can be given effect without the invalid portion, provided that such remaining portions or applications of this ordinance are not determined by the court to be inoperable.
