SPECIFICATION FOR SEWER CONNECTIONS

If an existing "Y" connection is not available, a "Y" type saddle must be installed on the sewer main. The location of "Y" type saddle must be reviewed and approved by the City's engineer. The excavation must be left open until inspected and approved by a City of Englewood (303-762-2635) and a City of Cherry Hills Village (303-762-8222) Inspector. Owner must give 24 hours notice to Inspector for final inspection. Permits are required by the City of Cherry Hills Village for street cuts. Street cut permits must be obtained prior to construction. All new sewer lines and replacement sewer lines shall require a building permit from the City of Cherry Hills Village and must be inspected by the City Building Inspector.

SEWER TAP PERMIT

City of Cherry Hills Village acknowledges receipt of \$_____ in payment of sewer user's tap charge and authorizes the City of Englewood, Colorado, to issue a permit to tap the City's sewer trunk line for the sanitary sewer service above described.
